- A. Assembly Bill 33 Board of Supervisors Vacancies
 - Cynthia Lau, Legislative Affairs Officer

Existing law gives the Governor the power of appointment to fill vacancies in county board of supervisors in the majority of California's counties.

There is no time requirement for the Governor to act.

AB 33 would amend the Government Code to set a 90 day limit for the Governor to make those appointments. Should the Governor fail to act within those 90 days, the affected board of supervisors would have the subsequent 90 days to act, by quorum vote, to either:

- 1. Appoint an individual of the board's choosing,
- 2. Call for a special election, or
- 3. Choose to leave the seat open until the next regularly scheduled election.

The current process has sometimes taken up to six months to fill vacancies. If the Governor fails to carry out his or her statutory duty, the passage of AB 33 provides authority to the board of supervisors to act.
