The meeting was called to order by Chairman Robbins at 11:10 a.m.

I. APPOINTMENT OF VOTING MEMBER(S) IN THE EVENT ONE OR MORE REGULAR COMMITTEE MEMBERS ARE ABSENT

All regular members of the Committee were present.

II. APPROVAL OF THE MINUTES OF THE REGULAR MEETING OF MARCH 15, 2012

A motion was made by Mr. Adams, seconded by Mr. de la Garza, to approve the minutes of the regular meeting of March 15, 2012. The motion passed unanimously.

III. ACTION ITEMS

A. Recommendation as submitted by Cynthia Lau, Legislative Affairs Officer: That the Committee recommend the Board of Retirement adopt a "Watch" position on Assembly Bill 1885, which addresses reciprocity upon reemployment after layoff. (Memorandum dated March 21, 2012)

A motion was made by Mr. de la Garza, seconded by Mr. Adams, to approve the recommendation. The motion passed unanimously.

B. Recommendation as submitted by Cynthia Lau, Legislative Affairs Officer: That the Committee recommend the Board of Retirement adopt a "Watch" position on Assembly Bill 2115, which caps defined benefit pensions at \$173,987 per year. (Memorandum dated April 3, 2012)

On April 10, this bill was amended and gutted, and no longer applies to pension caps, but now relates to employment contracts between hospital districts and hospital administrators. Therefore, the Committee did not take a position on AB 2115.

C. Recommendation as submitted by Cynthia Lau, Legislative Affairs Officer: That the Committee recommend the Board of Retirement adopt a "Support" position on Senate Bill 996, which codifies heart trouble as a rebuttable presumption. (Memorandum dated March 27, 2012)

A motion was made by Mr. Adams, seconded by Mr. Morris, to approve the recommendation. The motion passed with Mr. Russin voting no.

D. Recommendation as submitted by Cynthia Lau, Legislative Affairs Officer: That the Committee recommend the Board of Retirement adopt an "Oppose" position on Senate Bill 1231, which addresses STAR COLA benefits. (Memorandum dated April 4, 2012)

A motion was made by Mr. de la Garza, seconded by Mr. Russin, to approve the recommendation. The motion passed unanimously.

E. Recommendation as submitted by Cynthia Lau, Legislative Affairs Officer: That the Committee recommend the Board of Retirement adopt a "Watch" position on Senate Bill 1382, which relates to retiree organizations. (Memorandum dated March 28, 2012)

A motion was made by Mr. de la Garza, seconded by Mr. Russin, to adopt a "Support" position on Senate Bill 1382. The motion passed unanimously.

Effective July 1, 2012, a new state mandate expands maternity benefits to cover all pregnancies, both prenatal and neonatal. This will effect Blue Cross Anthem Plans I and II, which currently cover only complex pregnancies. All other LACERA plans currently offer full maternity coverage.
