A. Staff Activities Report for November, 2012

The staff activities report was discussed.

B. Medicare Part B Reimbursement Program for 2013

On November 16, 2012, the Centers for Medicare & Medicaid Services (CMS) announced the Medicare Parts A & B premium and coinsurance rates for 2013. The standard Part B premium will increase \$5.00, bringing the total monthly premium to \$104.90. Based on an analysis conducted by both Aon and Buck Consultants, the Los Angeles County Chief Executive Office has indicated that their recommendation to the Board of Supervisors will be to continue the reimbursement program and pay the applicable standard premium to eligible members.

C. Anthem Prudent Buyer and Plans I, II, & III Reserve Analysis

Aon reported on the results of the analysis of the Anthem Prudent Buyer and Plans I, II, and III reserves held by LACERA. Approximately \$65.2 million of LACERA's OPEB Reserve Account is allocated to the medical plans.

The Prudent Buyer Plan has a 5% margin built into premiums and is on a retroactive funding basis, meaning that Anthem can call upon additional funds

from LACERA if premiums do not cover costs. Plans I, II, and III have no explicit margin built into the rates, and no retroactive amounts can be called in the event of poor experience. All of the Anthem plans have refund arrangements to return to LACERA, in a given plan year, any surpluses accumulated on an annual basis. In fact, LACERA has received funds in the last few years.

Medical claims are susceptible to volatility owing to the inherent unpredictability of the frequency and severity of large claims. Anthem has incorporated conservative assumptions into rate setting and in calculating Incurred But Not Reported (IBNR) reserves. Aon concluded that the reserves are more conservative than necessary to cover LACERA in an adverse claims year. At minimum, Aon suggests releasing approximately \$39.2 million of the reserves, with the remaining \$26 million held to cover catastrophic claims occurrences and severity, and a 5% retrospective premium reserve for the Prudent Buyer Plan.
