II. APPROVAL OF THE MINUTES OF THE REGULAR MEETING OF DECEMBER 13, 2012

A motion was made by Mr. Kehoe, seconded by Mr. de la Garza, to approve the minutes of the regular meeting of December 13, 2012. The motion passed with Ms. Gray and Mr. Bernstein abstaining.

A. Staff Activities Report for December, 2012

The staff activities report was discussed.

B. CIGNA & Anthem Blue Cross Claims Experience

The CIGNA & Anthem Blue Cross Claims Experience reports through November 2012 were discussed.

C. Pre-Renewal Update

Aon has received initial rates for all LACERA carriers except SCAN. These rates are before further negotiations. Overall, all increases are in single digits, with senior advantage plans coming in very low, anywhere between a rate pass to a low single digit increased. Anthem I, II, and III combined is somewhere between 5-7%, with Anthem Prudent Buyer slightly lower. United Healthcare is under 5%. Kaiser is coming in lower than expected after preliminary discussions. The CIGNA Dental/Vision rates are very low, with the CIGNA HMO at a high single digit increase.

- D. Federal Legislation
 - Aon Hewitt Washington Report

The proposed reinsurance fee, which will apply to all plan sponsors for 2014, 2015, and 2016, is likely to pass. This fee is designed to help fund the risk that the state exchanges will take on. As it stands now, the fee will be \$63 per member per year. Excluded are self-funded ERISA plans, and post-65 Medicare retirees where Medicare is primary.

III. FOR INFORMATION (Continued)

Permissible incentives for wellness programs have been increased from 20% to 30% of the cost of coverage.

A further increase in incentives to 50% of the cost of coverage for smoking cessation.

Clarification on the regulations relating to calculating minimum essential benefits. Healthcare reform requires a 60% minimum essential benefit, meaning that those covered under a program receive at least 60% of the cost of care.

E. Caremark Informational Session

A question and answer session was held with representatives from Caremark regarding recent unfavorable media coverage. Items discussed were the voluntary manufacturer recall of a generic Lipitor, and recent auto refill problems.
