  - A. <u>Proposed Ballot Initiative "Pension Reform Act of 2014"</u> Cynthia Lau, Legislative Affairs Officer

This statewide initiative was recently released for signature gathering. It is intended for the 2014 ballot and was submitted as a constitutional amendment addressing pension benefits. Subsequent to the Legislative Analyst's Office preparing their analysis of the measure, the Attorney General of California issued a formal title and summary of the chief purpose and points of the proposed measure. The first sentence of the summary states that the measure "eliminates constitutional protections for vested pension and retiree healthcare benefits for current public employees, including teachers, nurses, and peace officers, for future work performed." Mayor Chuck Reed, one of the filers of this initiative, called this summary bogus and maintains it would not take away public workers constitutional rights.

In addition to labor opposing the measure, there was a coalition of more than two dozen mayors, county supervisors, city council members, and other elected officials who signed a letter to Mayor Reed asking him to end his effort on the initiative, stating they believed that pension matters were best decided locally at the bargaining table as opposed to on the ballot. Media reports note that it could take weeks before supporters even attempt to put this on the ballot, or they could decide to delay their plans until 2016. If they decide to pursue this further for the November 2014 ballot, they have until June 5 to collect a little over 800,000 signatures.

Mr. Kehoe requested staff present this item to the full Board.
