Diane Patzlaff and Molly McCoy of Anthem Blue Cross discussed the data breach which occurred in January of this year, and answered questions from the Committee.

Anthem is taking every precaution to make certain that their systems are protected, now and in the future. The FBI has informed Anthem that, to date, there is no indication that any of the data is being misused for the purposes of fraud. The critical member data obtained in the breach were name, address, social security number, date of birth, and email address. No medical, financial, premium, credit card, provider, or claims information was acquired.
