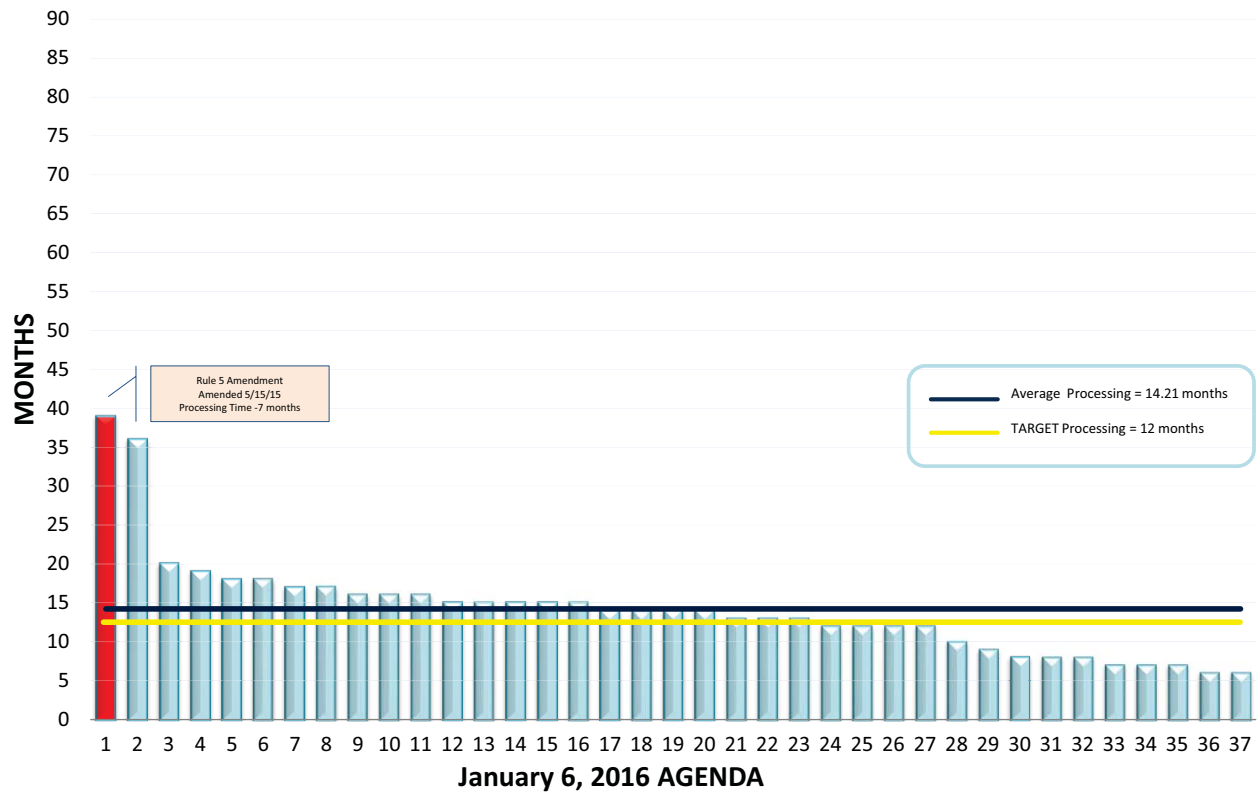
SUBJECT: **Application Processing Time Snapshot Reports**

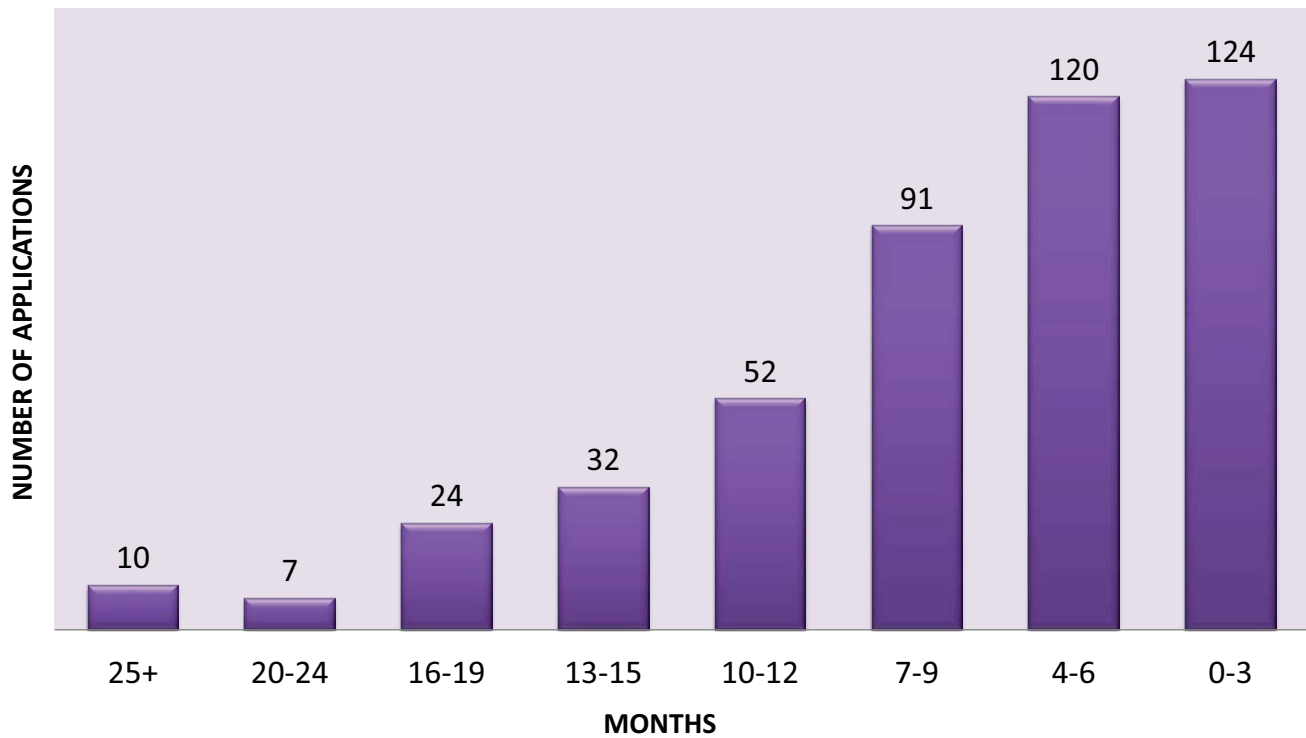
