Membership Pursuant to Government Code Section 31680.4 and

Government Code Sections 31680.4 and 31680.5 permit a service retired member to be re-employed by the County and reinstated as an active member of LACERA if the Board of Retirement, based upon medical examination, determines that the member is not incapacitated for the assigned duties. The member's retirement allowance would be suspended immediately upon re-employment. Reinstatement to active membership becomes effective the first day of the month following the date of re-employment. The returning member would only be eligible for a retirement plan that is currently available for new members regardless of the member's prior retirement plan.

Stephen R. Whitmore was employed by the Los Angeles County Sheriff's Department. He retired on January 30, 2016. The Office of the Assessor now wishes to re-employ Stephen R. Whitmore as a Special Assistant, Assessor (UC) (Item #9985).

Under CERL 31680.5, all reinstated general members are entitled to a retirement allowance, upon subsequent retirement, "determined as if the member were first entering the system." Thus, this member is only eligible for Retirement Plan G General. Note that the member was in Plan D for his past membership period and will be in Plan G General for his new membership period, if approved for reinstatement.

Attached are copies of documents prepared in support of the member's application for reinstatement:

- The November 26, 2019 letter from the Office of the Assessor confirming the Board of Supervisors' Stamp Approval of the request to re-employ the member. (Attachment 1)
- The letter from the member to LACERA requesting reinstatement of membership as a Special Assistant, Assessor with the Office of the Assessor. (Attachment 2)

- Note: The Special Assistant, Assessor position is an "Unclassified" (UC) position, thus, there is no Class Specification for Item No. 9985. However, the Office of the Assessor provided a list of duties for the position as a Special Assistant, Assessor. (Attachment 5)

IT IS THEREFORE RECOMMENDED THAT YOUR BOARD:

- 1. Determine, based upon medical evaluation conducted October 11, 2019, that Stephen R. Whitmore is not incapacitated for the duties assigned to him in the position of Special Assistant, Assessor; and

(ALL SUPERVISORIAL DISTRICTS - 3 VOTES)

SUBJECT:

The Office of the Assessor (Assessor) is requesting that your Board approve a Los Angeles County Employees Retirement Association (LACERA) member's return to service, thereby suspending the member's retirement benefits and returning to active full-time employment with the Assessor.

IT IS RECOMMENDED THAT THE BOARD OF SUPERVISORS

Authorize the Assessor's re-employment of retired LACERA member, Stephen R. Whitmore, to full-time permanent status in compliance with the County Employees Retirement Law of 1937 and Board Policy Number 9.150.

PURPOSE/JUSTIFICATION OF RECOMMENDED ACTION

Retired former County of Los Angeles employee, Stephen R. Whitmore, retired from County service effective January 30, 2016. Consistent with existing County Board Policy 9.150, which allows for the re-employment of retired County employees on an indefinite basis, the Assessor is requesting your Board's approval to re-employ County retiree Stephen R. Whitmore, pursuant to Civil Service Rule 17.01(a), as a permanent Special Assistant, Assessor (UC), Item Number 9985A.

Upon his return to County employment, Mr. Whitmore's retirement allowance will be suspended until the termination of his re-employment.

Currently, Mr. Whitmore is serving as a 120-Day Rehire Retiree for the Assessor, assisting with the Assessor's public affairs initiatives, such as coordinating internal and external communications and outreach efforts in government and community relations, providing staff support, and drafting press releases.

It is critical the Assessor hire Mr. Whitmore as soon as possible, as the Assessor's Public Affairs Unit is inundated with inquiries and requests particularly regarding the Assessor's efforts to assist homeowners affected by the recent fires throughout the County. Mr. Whitmore is a seasoned media/public affairs representative. His extensive public relations experience make him an asset to the Assessor's Public Affairs team.

Implementation of Strategic Goals

This recommended action is consistent with the County's Strategic Plan Goal 3, Realize tomorrow's government today by pursuing operational effectiveness, fiscal responsibility and accountability.

FISCAL IMPACT/FINANCING FACTS

The cost of the recommended salary will be absorbed within the Assessor's current budget.

FACTS AND PROVISIONS/LEGAL REQUIREMENTS

LACERA is governed by the County Employees Retirement Law of 1937. This action is in compliance with Government Code Sections 31680.4 and 31680.5, pertaining to retired members returning to active membership.

Prior to 1991, retired County employees were prohibited from returning to County employment, except temporarily and under limited circumstances. Government Code Section 31680.4 now permits retirees to return to work on a permanent basis. Your Board's adoption of Board Policy 9.150 on July 6, 1993, made this Government Code provision operative in Los Angeles County.

The Board letter has been reviewed and approved as to form by County Counsel.




