Staff Recommendation: Support

RECOMMENDATION

That the Board of Retirement adopt a “Support” position on Assembly Bill 2937, which would provide that a board of supervisors may adopt a resolution to remove intemperate use of alcoholic liquor or drugs as a factor that reduces a nonservice-connected disability retirement allowance.

LEGISLATIVE POLICY STANDARD

AB 2937 is sponsored by the State Association of County Retirement Systems (SACRS). A proposal to preclude intemperate use of alcoholic liquor or drugs as a factor that reduces a nonservice-connected disability retirement allowance was initiated by LACERA on September 4, 2019 for the SACRS membership to consider for sponsorship, which SACRS approved. The Board of Retirement’s Legislative Policy authorizes staff to engage with LACERA’s legislative advocate to achieve passage of sponsored and supported proposals (Legislative Policy, page 8).

SUMMARY

AB 2937 would authorize a board of supervisors to adopt a resolution that would not include the intemperate use of alcoholic liquor or drugs as a factor that reduces a nonservice-connected disability retirement allowance.

ANALYSIS

Existing Law

Government Code Sections 31726 (which applies to general members) and 31726.5 (which applies to safety members) provide for the calculation of a disability retirement allowance for members who are granted a nonservice-connected disability retirement. The disability retirement allowance for general members under age 65 and safety members under age 55 is the greater of a service retirement allowance or the sum of an annuity that is the actuarial equivalent of the member's accumulated contributions and a disability retirement pension purchased by contributions of the county.

Such a member is not entitled to a disability retirement pension purchased by contributions of the county if the member's disability is due to intemperate use of alcoholic liquor or drugs, willful misconduct, violation of law on the member's part, or (for those who became members on or after January 1, 1988) conviction of a felony or criminal activity that caused or resulted in the member's disability.

Government Code Section 31838 provides for the calculation of a disability retirement allowance for reciprocal members who are granted a nonservice-connected disability retirement and similarly precludes a disability retirement pension purchased by contributions of the county if the member's disability is due to the intemperate use of alcoholic liquor or drugs, willful misconduct, or violation of law on the member's part.

This Bill

If a general member under age 65 or a safety member under age 55 is granted a nonservice-connected disability retirement due to the intemperate use of alcoholic liquor or drugs but is not entitled to a service retirement amount, then the member's retirement allowance may be limited if the allowance is based only on the member's accumulated contributions and not also on a disability retirement pension purchased by contributions of the county.

Since the county is the plan sponsor that provides the benefit of the disability retirement pension, AB 2937 would authorize a board of supervisors to adopt a resolution that would remove the intemperate use of alcoholic liquor or drugs as a factor that would preclude the purchase of a disability retirement pension by county contributions. If the board of supervisors adopts such a resolution, it would apply to retirements that are effective on or after the adoption of the resolution.

IT IS THEREFORE RECOMMENDED THAT THE BOARD adopt a "Support" position on Assembly Bill 2937, which would provide that a board of supervisors may adopt a

resolution to remove intemperate use of alcoholic liquor or drugs as a factor that reduces a nonservice-connected disability retirement allowance.

BOARD POSITIONS ADOPTED ON RELATED LEGISLATION

AB 664 (2019, In Senate Committee on Labor, Public Employment and Retirement) would require, for purposes of determining permanent incapacity of peace officers in Sacramento County, that they be evaluated by the retirement system to determine if they can perform the usual and customary duties of a peace officer. It would also require the board of retirement to develop a method to track the costs of providing disability retirement to members who are eligible under the bill's provisions. The Board of Retirement adopted an "Oppose" position.

AB 283 (2017, died in committee) required any members employed as peace officers, for purposes of disability retirement, to be evaluated under a retirement system's existing procedures to determine if he or she can perform all of the usual and customary duties of a peace officer based upon the standards for peace officers in Government Code Section 1031. The Board of Retirement adopted a "Neutral" position.

AB 1692 (Chapter 123, Statutes of 2016) applied the terms and conditions of disability retirement in Tier Three to nonsafety members of the Contra Costa Employees' Retirement Association who are subject to the California Public Employees' Pension Reform Act of 2013 and for whom the Board of Supervisors of Contra Costa County is the governing body. The Board of Retirement adopted a "Watch" position.

AB 992 (Chapter 40, Statutes of 2015) clarified that a member who retired for service pursuant to Government Code Section 31725.7 and is later granted a disability retirement may change the retirement option that he or she elected at the time the service retirement was granted. The Board of Retirement adopted a "Support" position.

AB 1902 (Chapter 86, Statutes of 2010) enabled Plan D members who transferred prospectively from Plan E but do not meet the requirements for disability retirement to transfer back to Plan E and continue to be eligible for long-term disability benefits from the County of Los Angeles. The Board of Retirement adopted a "Support" position.

AB 1739 (Chapter 83, Statutes of 2010) required that a member who becomes permanently incapacitated for the performance of duty as a direct result of injury or disease arising out of, and in the course of, active military service while on military leave, to be retired for nonservice-connected disability regardless of age or years of service. The section becomes operative upon adoption of a resolution by majority vote by the board of supervisors of Los Angeles County. The Board of Retirement adopted a "Watch" position.

AB 538 (Chapter 190, Statutes of 2009) provided a safety member who was on a disability leave of absence the opportunity to receive a physician certification upon his or her return to service that the member was capable of performing his or her assigned duties and consequently not subject to mandatory retirement prior to receiving that opportunity. The Board of Retirement adopted a "Watch" position.

LEGISLATIVE COUNSEL'S DIGEST

AB 2937, as introduced, Fong. CERL: non-service-connected disability retirement.

The County Employees Retirement Law of 1937 (CERL) authorizes counties to establish retirement systems pursuant to its provisions for the purpose of providing pension, disability, and death benefits to county and district employees. CERL prescribes the methods for calculating a non-service-connected disability retirement for different membership classifications and for the purpose of calculating reciprocal benefits. In these instances, the sum of allowance may vary depending on whether or not the retirement board finds, in its opinion, the member's disability is due to intemperate use of alcoholic liquor or drugs, among other things. In this regard, CERL conditions the purchase of a disability retirement pension by county or district contributions on a finding by the board that the member's disability is not the result of intemperate use of alcoholic liquor or drugs.

This bill would create an optional provision, to be elected by a county board of supervisors by resolution adopted by majority vote, that would remove the retirement board's assessment regarding the intemperate use of alcoholic liquor or drugs as a condition on the purchase of a disability retirement pension by county or district contributions.

Our plan sponsor, the County of Los Angeles, withdrew from participation in Social Security in 1983. Our older members may have earned Social Security benefits as county employees, whereas newer members may have earned Social Security benefits from private sector employment before moving into public service.

The Windfall Elimination Provision (WEP) and Government Pension Offset (GPO) have unfairly penalized workers in public service, and LACERA remains committed to pursuing complete repeal of the WEP and GPO. However, we believe that the WEP-only reform approach contained in H.R. 4540 is a significant first step toward that goal.

H.R. 4540 replaces the current WEP formula with a proportional formula to calculate a Social Security benefit based on the proportion of covered employment for those who begin receiving benefits in 2022. Social Security's Office of the Chief Actuary estimates that most future retirees will receive a higher average monthly benefit under the proportional formula.

At the same time, the bill provides protection provisions to ensure that current and future retirees do not receive lower benefits as a result of the new formula. The bill also provides immediate relief to current retirees receiving benefits affected by the WEP. They will receive up to \$150 per month to offset its effects, and the amount will be subject to annual cost-of-living increases.

Retirees have been unfairly penalized by the WEP for decades. Now is the time for Congress to take formal steps to lessen that burden. We encourage both parties in the House to work together in a bipartisan manner on WEP legislation that not only will pass the House but also will provide momentum for approval in the Senate.

The Windfall Elimination Provision (WEP) and Government Pension Offset (GPO) have unfairly penalized workers in public service, and LACERA remains committed to pursuing complete repeal of the WEP and GPO. However, we believe that the WEP-only reform approach contained in H.R. 3934 is a significant first step toward that goal.

H.R. 3934 replaces the current WEP formula with a proportional formula to calculate a Social Security benefit based on the proportion of covered employment for those who begin receiving benefits after 2021. Social Security's Office of the Chief Actuary estimates that most future retirees will receive a higher average monthly benefit under the proportional formula.

At the same time, the bill provides protection provisions during a transition period to ensure that new retirees between 2022 and 2060 do not receive lower benefits as a result of the new formula. The bill also provides immediate relief to current recipients of benefits affected by the WEP of \$100 per month to those receiving worker benefits and \$50 per month to those receiving spousal or children's benefits. These payments are subject to annual cost-of-living adjustments.



SUBJECT: PANEL PHYSICIAN EVALUATION REPORTS DURING THE SAFER-AT-HOME ORDER FOR CONTROL OF COVID-19

On March 21, 2020, the County of Los Angeles Department of Public Health issued its Safer-at-Home Order for the Control of COVID-19. This order impacted Disability Retirement Services' (DRS) practices with regard to the scheduling of in-person panel physician evaluations for our pending disability-retirement applications. The purpose of this memorandum is to inform the Board of Retirement of the steps DRS has taken in order to maintain the timely processing of its pending disability-retirement applications.

Currently, DRS maintains a Priority 1 Selection Criteria for the processing of certain disability retirement applications meeting specified criteria. The panel physicians in these cases provide an Independent Medical Evaluation (IME) report based on a record review.

Beginning March 25, 2020, DRS expanded its P-1 criteria to all pending disability retirement applications—this expansion does not apply to psychiatric evaluations. During the Safer-at-Home Order, LACERA panel physicians are requested to prepare an IME based on a record review. If the panel physician requires contact with a member, the physician may speak to the member over the telephone. If the panel physician is unable to issue an IME report based on a record review, the appointment will be rescheduled for a future date in anticipation of the lifting of the Safer-at-Home Order.

For psychiatric evaluations, DRS is allowing panel psychiatrists to conduct a video teleconference evaluation in conjunction with a record review. However, before any such evaluation is scheduled, the psychiatrist must provide proof of a HIPAA compliant telemedicine agreement. This requirement is to ensure members' privacy. As of the date of this memorandum only one psychiatrist, Perry Maloff, M.D., has provided proof of a HIPAA compliant telemedicine agreement. Other psychiatrists have not yet responded to our request.



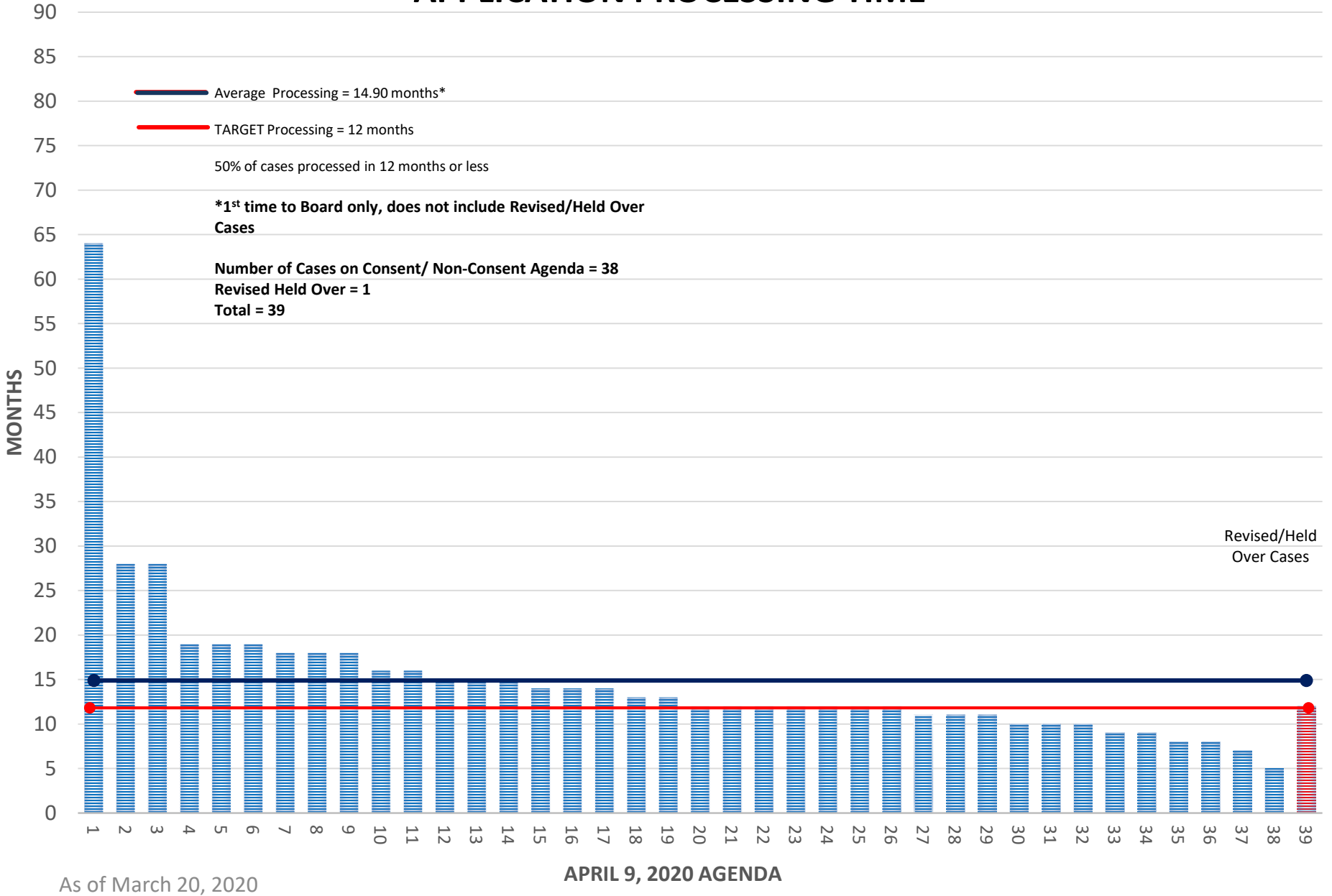

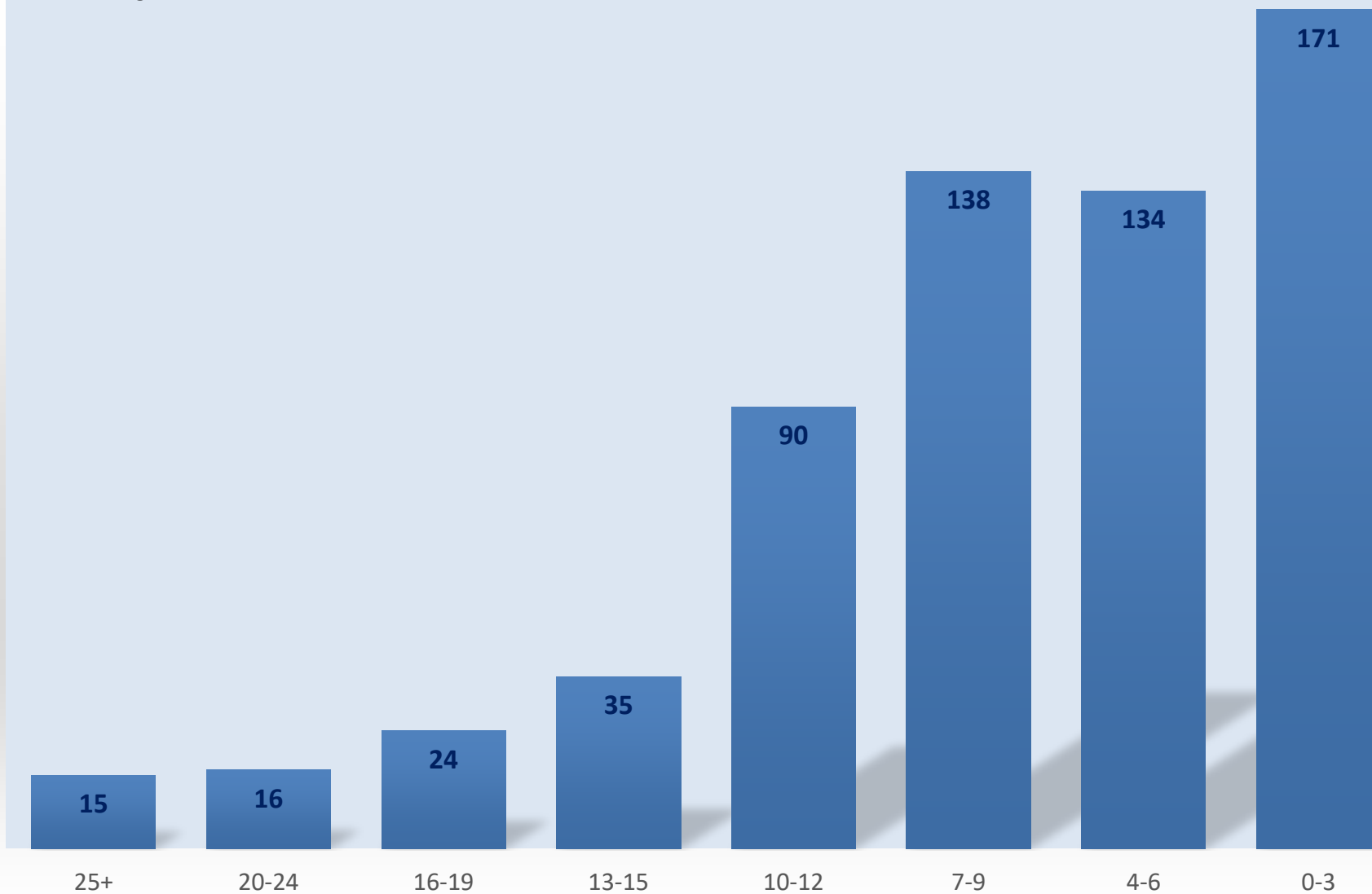
DISABILITY RETIREMENT SERVICES APPLICATION PROCESSING TIME
