**SUBJECT**: Investments Division Recruitment Report – March 2022

This report is provided as a supplement to the CEO Report included in the March 2022 agenda regarding filling the vacant positions in the Investments Division.

In collaboration with the Investment Office and Human Resources (HR), a timeline and hiring plan that reflects the staffing priorities of the Investment Team has been developed and is attached.

Open recruitment for the Principal Investment Officer is underway with promulgation of the hiring list to be completed no later than early next week. Final selection of the successful candidate by Mr. Grabel would follow soon thereafter.

The remaining Investment Tier I recruitments to fill a Senior Investment Officer in Private Equities, and various Finance Analyst III positions to fill vacancies in (1) Credit and Fixed Income, (1) Real Estate, and (2) Corporate Governance are expected to be released on a rolling basis between now and June 30, 2022.

A Request for Proposal (RFP) to secure an outside recruiter for the Deputy Chief Investment Officer position has been issued and will close on March 22, 2022, at which time recruitment efforts for this critical position will begin in earnest.

There are two (2) Finance Analyst II positions for Real Estate, Credit and Fixed Income, and (1) Principal Investment Officer position for Direct Investments classified as Tier II priority positions that are scheduled to be filled by the end of the calendar year.
